### Purpose

The Willows State School is committed to providing a safe, respectful and responsible learning environment for all students, staff, parents and visitors.

The Willows State School Student Code of Conduct sets out the responsibilities and processes we use in our school to promote a productive, effective whole school approach to discipline.

Its purpose is to facilitate high standards of behaviour from all in the school community, ensuring teaching and learning in our school is prioritised, all students are able to experience success and staff enjoy a safe workplace.

The Willows State School Student Code of Conduct affirms that students and teachers have the right to work to their potential, free from disruption, abuse or threat. It also affirms that parents/carers have a joint responsibility to encourage students to be accountable for their behaviour and to contribute to the wider school community in a positive manner.



### Principal's Foreword

#### Excellence is the Standard

The Willows State School has a long and proud tradition of providing high quality education to students across the North Queensland region. We believe strong, positive relationships between all members of our school are the foundation to supporting the success of all students.

The Willows State School has three core rules of being Safe, Respectful and Responsible.

Safe	ensure your daily actions or words do not cause harm to yourselves or others.
Respectful	act in accordance with principles of moral and ethical conduct, ensure consistency between words and deeds.
Responsible	be accountable for your actions, resolve differences in constructive, non-violent and peaceful ways, contribute to society and civic life and take care of the environment.

These rules have been used in the development of this Student Code of Conduct with the aim of helping shape and build the skills of all our students to be confident, selfdisciplined and kind young people. All school staff believe that communication and positive connections with other people are the most valuable skills our communities need now, and in the future.

The Willows State School staff take an educative approach to discipline, that behaviour can be taught and that mistakes are opportunities for everyone to learn. Our Student Code of Conduct provides an overview of the school's policies on use of mobile phones and other technology, removal of student property and the approach to preventing and addressing incidents of bullying. It also details the steps school staff take to educate students about these policies and how students are explicitly taught the expected behaviours. Finally, it details the consequences that may apply when students breach the expected standards of behaviour.

I thank the students, teachers, parents and other members of the community for their contributions in reviewing and refining our 2024-2025 edition of the Student Code of Conduct. Your interest and views shared throughout the process of developing this document have been invaluable.



### P&C Statement of Support

As president of The Willows State School P&C Committee, I am proud to support the revised Student Code of Conduct. The consultation process led by the school leadership team has ensured that parents have had multiple opportunities to contribute and provide feedback on the final document. This has been an important aspect in the development of The Willows State School Student Code of Conduct, as the awareness and involvement of parents/carers is critical to ensuring all adults are able to support the students of the school to meet behavioural expectations.

We encourage all parents/carers to familiarise themselves with The Willows State School Student Code of Conduct, and to take time to talk with their children about the expectations and discuss any support they may need. In particular, we want to emphasise the systems in place to help students affected by bullying.

Bullying is a community-wide issue which we all have a role to play in combating. It is important that parents and children know that schools provide support and advice to help address problems of bullying and the information contained within the Student Code of Conduct provides an excellent starting point to understand how to approach the school about these types of problems.

Any parents who wish to discuss The Willows State School Student Code of Conduct and the role of families in supporting the behavioural expectations of students are welcome to contact myself or to join The Willows State School P&C Association. It is with your support that we can work collaboratively with school staff to ensure all students are safe and appropriately supported to meet their individual social and learning needs.

### School Leaders' Statement

On behalf of the student body at The Willows State School, we endorsed the Student Code of Conduct for 2024-2025 in the Term 4 student council meetings. We have represented students on the consultation committee, provided feedback on draft materials and put forward the views of young people on a range of issues affecting their lives at school. Throughout the coming years school leaders will continue to work with the school administration team and The Willows State School P&C Association on how the Student Code of Conduct is working, identify areas for improvement and present alternative options or suggestions for consideration.



### Consultation

The consultation process used to inform the development of The Willows State School Student Code of Conduct occurred in three phases.

In the first phase, we held a series of internal meetings with staff. During these meetings, we examined a range of data sets relating to attendance, PBL, school disciplinary absences and school opinion surveys. We identified strengths and successes from our previous Student Code of Conduct, and identified areas for further development in alignment with changing DoE policies and procedures.

In the second phase, a draft Student Code of Conduct was prepared and distributed for comment to all members of the school community. The third phase of consultation was completed in Term 4, 2023, when the finished version, incorporating suggested changes and feedback, was sent to the P&C Association for review. The P&C Association unanimously endorsed The Willows State School Student Code of Conduct in November, 2023, for implementation from 2024.

A communication strategy has been developed to support the implementation of The Willows State School Student Code of Conduct, including parent information sessions, promotion through the school website, weekly newsletter and school Facebook page.

#### **Review Statement**

The Willows State School Student Code of Conduct will undergo annual minor updates to reflect any changed policies and procedures. A full review will be conducted in alignment with the scheduled review processes of the School Planning, Reviewing and Reporting Framework. The most current version of the document will always be available from the school website.



### Learning and Behaviour Statement

Everyone brings their own set of personal beliefs to a school community. These beliefs influence their decisions, behaviour and social practices. It is reasonable to expect that not everyone will share the same set of beliefs, and this contributes to a richly diverse social environment in each school. It can also contribute to differences in expectations and force us to reflect on our own understanding of what we consider acceptable and unacceptable. We encourage any student or parent to make an appointment with a member of the school Leadership Team through Administration to discuss the model of behaviour support and discipline used at this school.

### Student Wellbeing and Support Network

### Student Wellbeing

The Willows State School offers a range of programs and services to support the wellbeing of students in our school. We encourage parents/carers to arrange a time to speak with one of the school Leadership Team members if they have concerns about their child. The leadership team member may do a referral to the School's Guidance Officer if specialised assistance is required.

Learning and wellbeing are inextricably linked — students learn best when their wellbeing is optimised, and they develop a strong sense of wellbeing when they experience success in learning. The <u>Student Learning and Wellbeing Framework</u> supports state schools with creating positive school cultures and embedding student wellbeing in all aspects of school life through connecting the learning environment, curriculum and pedagogy, policies, procedures and partnerships for learning and life.

#### Curriculum and pedagogy

Schools build the foundations for wellbeing and lifelong learning through curriculum embedding <u>personal and social capabilities</u> (self-awareness, self-management, social awareness and social management) in the implementation of the V9 <u>Australian</u> <u>Curriculum</u> and P–12 curriculum, assessment and reporting framework.

Schools acknowledge the positive impact that meaningful relationships between teachers and students can have on students' academic and social outcomes. As part of the whole school's curriculum plan at The Willows State School, we provide ageappropriate health education which includes programs such as the Respect program, Bravehearts and Life Education.

### **Policy and expectations**

Within a school community there are specific health and wellbeing issues that will need to be addressed for the whole school, specific students, or in certain circumstances.

#### Drug education and intervention

The Willows State School implements drug intervention measures for students involved in drug-related incidents at school, during school activities or while in school uniform. This is managed to protect the health and safety of the student/s involved, other students, school staff and the wider community.



#### Specialised health needs

The Willows State School works closely with parents/carers to ensure students with specialised health needs, including those requiring specialised health procedures, have access to a reasonable standard of support for their health needs whilst attending school or school-based activities.

This means that appropriate health plans are developed and followed for students with specialised health needs. We ensure that staff are aware of the student's medical condition and that an appropriate number of staff have been trained to support the student's health condition. Parents/Carers are responsible for providing the most up-to-date health plans to the school.

#### Medications

The Willows State School requires parent consent and medical authorisation to administer any medication (including over-the-counter medications) to students. For students requiring medication to be administered during school hours, the school can provide further information and relevant forms.

For students with a long-term health condition requiring medication, parents/carers need to provide the school with a Request to administer medication at school form signed by the prescribing health practitioner.

The Willows State School maintains a minimum of one adrenaline auto-injector and asthma reliever/puffer, stored in the school's/campus first aid kit to provide emergency first aid medication if required.

#### Mental health

The Willows State School implements early intervention measures and treatments for students where there is reasonable belief that a student has a mental health difficulty. This includes facilitating the development, implementation and periodic review of a Student Plan. The school staff can facilitate with care givers referrals to appropriate external agencies when required.

#### Suicide prevention

The Willows State School staff who notice suicide warning signs in a student will seek help immediately from the Deputy Principal/Principal who will engage the Guidance Officer. When dealing with a mental health crisis, schools call 000 when there is an imminent threat to the safety of the student in the first instance, and where necessary provide first aid. In all other situations, The Willows State School staff follow suicide intervention and prevention advice by ensuring:

- the student is not left alone
- their safety and the safety of other students and staff is maintained
- students receive appropriate support immediately
- parents/carers are advised
- all actions are documented and reported.

#### Suicide postvention

In the case of a suicide of a student that has not occurred on school grounds, The Willows State School enacts a postvention response, by communicating with the family



of the student and ensuring timely support is provided to students and staff who may be affected.

Where a suicide has occurred on school grounds or at a school event, The Willows State School staff immediately enact the School Emergency Management Plan and communicate with the family of the student and ensure immediate support is provided to students and staff who may be affected.

### Student Support Network

The Willows State School is proud to have a comprehensive Student Services Support Team (SSST) in place to help the social, emotional and physical wellbeing of every student. In addition to the assistance provided by class teachers, we have a team of professionals whose dedicated roles are to help ensure our school is an inclusive, nurturing environment.

Students can approach any school staff member at The Willows State School to seek assistance or advice. If they are unable to assist, they will provide guidance and help ensure the student is connected to the appropriate representative of the Student Support Team.

### Whole School Approach to Discipline

The Willows State School uses Positive Behaviour for Learning (PBL) as the multitiered system of support for discipline in the school. This is a whole-school approach, used in all classrooms and programs offered through the school, including music, technology and sporting activities, as well as excursions.

PBL is an evidence-based framework used to:

- analyse data and improve student behaviour and learning outcomes
- ensure that only evidence-based practices are used correctly by teachers to support students
- support staff members to maintain consistent school and classroom improvement practices

At The Willows State School, we believe discipline is about more than receiving a consequence. Discipline reflects our belief that student behaviour is a part of the overall teaching and learning approach in our school. Our staff take responsibility for making their expectations clear, for providing explicit and supportive instruction about how to meet these expectations and strive to use behavioural incidents as opportunities to reteach.

The development of The Willows State School Student Code of Conduct is an opportunity to explain the PBL framework with parents/carers and students to gain support in implementing a consistent approach to teaching behaviour. The language and expectations of PBL can be used in any environment, including the home setting for students. Supporting students to be successful is a shared goal of every parent and school staff member.

Any students or parents/carers who have questions or would like to discuss the Student Code of Conduct or PBL are encouraged to speak with their class teacher first and then make an appointment to meet with a Leadership Team member if needed.

### **Consideration of Individual Circumstances**

Staff at The Willows State School take into account students' individual circumstances, such as their behaviour history, disability, mental health and wellbeing, religious and cultural considerations, home environment and care arrangements when teaching expectations, responding to inappropriate behaviour or applying a disciplinary consequence.



In considering the individual circumstances of each student, we recognise that the way we teach, the support we provide and the way we respond to students will differ. This reflects the principle of equity, where every student is given the support they need to be successful. This also means that not everyone will be treated the same, because treating everyone the same is not fair. For example, some students need additional support to interpret or understand an expectation. Others may benefit from more opportunities to practise a required skill or behaviour. For a small number of students, the use of certain disciplinary consequences may be considered inappropriate or ineffective due to complex trauma or family circumstances. These are all matters that our teachers and administration staff consider with each individual student in both the instruction of behaviour and the response to behaviour.

Our teachers are also obliged by law to respect and protect the privacy of individual students, so while we understand the interest of other students, staff and parents/carers to know what consequence another student might have received, we will not disclose or discuss this information with anyone but the student's family. This applies even if the behavioural incident, such as bullying, involves your child. You can be assured that school staff take all matters, such as bullying, very seriously and will address them appropriately. We expect that parents/carers and students will respect the privacy of other students and families.

If you have concerns about the behaviour of another student at the school, or the way our staff have responded to their behaviour, please make an appointment with one of the Leadership Team to discuss the matter.

### **Differentiated and Explicit Teaching**

The Willows State School is a safe, supportive and disciplined school environment that provides differentiated teaching to respond to the learning needs of all students. This involves teaching expected behaviours and providing opportunities for students to practise these behaviours. Teachers reinforce expected behaviours, provide feedback and correction, and opportunities for practise.

Teachers at The Willows State School follow The Australian Curriculum and differentiate to support student engagement and positive behaviour. These decisions about differentiation are made in response to data and day-to-day monitoring that indicates the behavioural learning needs of students. This enables our teachers to purposefully plan a variety of ways to engage students; assist them to achieve the expected learning; and to demonstrate their learning.

There are three main layers to differentiation, as illustrated in the diagram below.

These three layers map directly to the multi-tiered approach that is discussed in the next section.

Every classroom in our school uses the PBL Expectations Matrix, see appendix 1, as a basis for developing their behaviour standards. Using this matrix, the class teacher works with all students to explain exactly what each of the expectations look, sound and feel like in their classroom. The matrix is on display in every classroom, used as the basis of teaching expectations throughout the year and revisited regularly to address any new or emerging issues.

### **Multi-Tiered Systems of Support**

The Willows State School uses multi-tiered systems of support (MTSS) as the foundation for our integrated approach to learning and behaviour. MTSS is a preventative, differentiated model grounded in practical strategies, targeted planning and data-informed decision-making. Based on a problem-solving model, in MTSS school staff match increasingly intensive interventions to the identified needs of individual students.

Tier	Description				
1	<u>All students</u> (100%) in the school receive an inclusive and differentiated curriculum which is responsive to their academic and behavioural development. Focus is on the whole-school implementation of both the Australian Curriculum and Positive Behaviour for Learning (PBL) expectations. This involves:				
	<ul> <li>teaching behaviours in the setting they will be used, eg: classroom or playground</li> <li>being consistent when addressing challenging behaviour, while taking developmental norms and behavioural function into account</li> <li>providing refresher lessons and targeted recognition throughout the school year so skills are ready and likely to be used when students need them</li> <li>asking students and their families for their perspectives on school climate, instruction, reinforcement, and discipline so improvements in Tier 1 may be made.</li> </ul>				
2	Targeted instruction and supports for <b><u>some students</u></b> (10-15%) are more intense than Tier 1 services, providing more time and specialisation in services from a range of school-based staff to enable students to meet the required academic and behavioural standards.				
	Tier 2 supports build on the lessons provided at Tier 1, and may prevent the need for more intensive interventions. Tier 2 supports are provided to small groups of students with similar needs, offering more time and/or detailed instruction on the Australian Curriculum or particular aspects of Positive Behaviour for Learning (PBL) expectations. The types of interventions offered at this level will vary according to the needs of each school's student body, but all have certain things in common:				
	<ul> <li>there is a clear connection between the skills taught in the interventions and the school-wide expectations</li> <li>interventions require little time of classroom teachers and are easy to sustain</li> <li>variations within each intervention are limited</li> <li>interventions have a good chance of working (e.g. they are "evidence-based" interventions that are matched to the student's need).</li> </ul>				



	If the school data indicates that more than 10-15% of students require targeted services, then a review of Tier 1 is needed to address the basic implementation and quality of instruction.				
3	Individualised services for <u>few students</u> (2-5%) who require the most intensive support a school can provide. These are usually delivered in very small groups or on an individual basis.				
	Tier 3 supports continue to build on the lessons and supports provided at Tiers 1 and 2, becoming more individualised and more intensive until teams can identify what is needed for a student to be successful. Tier 3 supports are based on the underlying reasons for a student's behaviour as assessed through a Functional Behaviour Assessment (FBA) and should include strategies to:				
	<ul> <li>PREVENT problem behaviour</li> <li>TEACH the student an acceptable replacement behaviour</li> <li>REINFORCE the student's use of the replacement behaviour</li> <li>MINIMISE the payoff for problem behaviour.</li> </ul>				
	Many students can benefit from a simple (or brief) Functional Behaviour Assessment that identifies unique strategies to help the student achieve success. A smaller percentage of students may require a more comprehensive FBA that includes a more thorough process for data collection, teaming, and problem solving. A much smaller percentage of students may need an intensive FBA and wrap around plan that includes personnel from outside agencies and rigorous problem-solving procedures.				
	If the school data indicates that more than 2-5% of the student population requires individualised services, a review of Tier 1 and Tier 2 supports and organisation is recommended.				

### **Focused Teaching**

Approximately 15% of all students in any school or classroom may require additional support to meet behaviour expectations, even after being provided with differentiated and explicit teaching. These students may have difficulty meeting behavioural expectations in a particular period of the day or as part of a learning area/subject, and focused teaching is provided to help them achieve success.

Focused teaching involves revisiting key behavioural concepts and/or skills and using explicit and structured teaching strategies in particular aspects of a behaviour skill. Focused teaching provides students with more opportunities to practise skills and multiple opportunities to achieve the intended learning and expected behaviour.

Support staff, including teachers with specialist expertise in learning, language or development, work collaboratively with class teachers at The Willows State School to provide focused teaching. Focused teaching is aligned to the PBL Expectations Matrix, and student progress is monitored by the classroom teacher/s to identify those who:

- no longer require the additional support
- require ongoing focused teaching
- require intensive teaching



Our school invests in the following programs to address specific skill development for some students:

### Intensive Teaching

Research evidence shows that even in an effective, well-functioning school there will always be approximately 5% of the student population who require intensive teaching to achieve behavioural expectations. Intensive teaching involves frequent and explicit instruction, with individuals or in small groups, to develop mastery of basic behavioural concepts, skills and knowledge.

Some students may require intensive teaching for a short period, for particular behaviour skills. Other students may require intensive teaching for a more prolonged period. Decisions about the approach will be made based on data collected from their teacher or teachers, and following consultation with the student's family.

For a small number of students who continue to display behaviours that are deemed complex and challenging, individualised, function-based behaviour assessment and support plans and multi-agency collaboration may be provided to support the student. This approach will seek to address the acute impact of barriers to learning and participation faced by students who are negotiating a number of complex personal issues.

### **PBL Expectations**

#### Staff

Our staff are committed to delivering a high quality education for every student, and believe all adults in the school, whether visiting or working, should meet the same three Positive Behaviour for Learning (PBL) expectations in place for students, being Safe, Respectful and Responsible.

#### Students

Below are examples of what these PBL expectations look like for students across the school. In addition, each classroom will have their own set of examples to help students and visitors understand the expectations and meet the standards we uphold for everyone at The Willows State School.


### Positive Recognition Schedule

At The Willows State School we have a systematic, consistent, school-wide approach to reinforcing and acknowledging expected behaviours. We respond to students with specific, timely and constructive feedback and recognition, in turn supporting students to learn and practise the behaviours that are expected in and outside of the classroom.

At The Willows State School we use three levels of acknowledgment.

- free and frequent for everyday use by all staff in all school settings
- moderate and intermittent awarded occasionally
- significant and infrequent quarterly or yearly types of recognition

### Free and Frequent

### WOWs - Playground

WOWs are given to students by staff. These acknowledgements are given when the student is modelling the school wide expectations of Safe, Respectful and Responsible behaviour in the playground. The WOWs are drawn on the year level parades and the winner receives a treat from the tuckshop.



### **Reach for the Stars - Classroom**

The purpose of this system is to encourage and acknowledge students' effort and good behavioural choices within the classroom. This builds confidence and self-esteem, encouraging the students to display outstanding behaviour in line with the schools expectations. It is also a very useful tool in providing parents/carers feedback regarding their child's behaviour during school time. The strengths of this chart system are –

- Students self-regulate;
- Easy to understand the steps;
- Students are proud when they can see themselves moving up the colours;
- Focus is positive;
- Students have something to consistently aim for;
- Visual reference for students and teachers.



Classroom Star Chart -

Free and Frequent Stars

#### STARS - Classroom

Stars are a free and frequent tool in the classroom that sits alongside the 'Reach for the Stars' system. They are stamped on a sheet and it is a goal for the students to collect 75 every 5 weeks to attend the mid term and end of term star celebrations.

#### **Class Awards**

Teachers present Attendance, Behaviour and Excellence certificate awards at the Class Cohort Parades.

- Parades are led by the Classroom Teachers (Administration Team may also attend)
- Cohort parades will cover A attendance, B behaviour, C celebrations, D demonstrations,
   E excellence in learning and friends, F Fortnightly PBL Lessons, G General messages.
- Teachers enter the students who received the Attendance, Behaviour and Excellence certificates onto OneSchool as a positive entry

### 75 Star and Silver Star Rewards

To promote positive behaviour for learning at The Willows all staff and students follow the Reward Schedule. Twice a term in week 5 and 10 students who have reached 75 stars attend the celebration with their class. Students who do not have a major incident in the term are then rewarded at the Silver Star celebration in week 10.

### **Disciplinary Consequences**

The differentiated responses to problem behaviour can be organised into three tiers, with increasing intensity of support and consequences to address behaviour that endangers others or causes major, ongoing interference with class or school operations.

The majority of students will be confident and capable of meeting established expectations that are clear, explicitly taught and practised. In-class corrective feedback, sanctions and rule reminders may be used by teachers to respond to low-level or minor problem behaviours.

Some students may need additional support, time and opportunities to practise expected behaviours. Approximately 15% of the student population may experience difficulty with meeting the stated expectations, and even with focused teaching, in-class corrective feedback, sanctions and rule reminders continue to display low-level problem behaviour. A continued pattern of low-level behaviour can interfere with teaching and learning for the whole class, and a decision may be needed by the class teacher to refer the student to the school administration team immediately for determination of a disciplinary consequence.

For a small number of students, approximately 2-5%, a high level of differentiated support or intensive teaching is required to enable them to meet the behavioural expectations. This may be needed throughout the school year on a continuous basis. The determination of the need will be made by the principal in consultation with staff and other relevant stakeholders. On occasion the behaviour of a student may be so serious, such as causing harm to other students or to staff, that the principal may determine that an out of school suspension or exclusion is necessary as a consequence for the student's behaviour. Usually, this course of action is only taken when the behaviour is either so serious as to warrant immediate removal of the student for the safety of others, and no other alternative discipline strategy is considered sufficient to deal with the problem behaviour.

The Willows State School takes into consideration individual circumstances when applying disciplinary consequences for behaviour.

### Differentiated

Class teacher provides in-class or in-school disciplinary responses to low-level or minor problem behaviour. This may include:

- Pre-correction (e.g. "Remember, walk quietly to your seat")
- Non-verbal and visual cues (e.g. posters, hand gestures)
- Whole class practising of routines
- Ratio of 5 positive to 1 negative commentary or feedback to class
- Corrective feedback (e.g. "Hand up when you want to ask a question")
- Rule reminders (e.g. "When the bell goes, stay seated until I dismiss you")
- Explicit behavioural instructions (e.g. "Pick up your pencil")
- Proximity control
- Tactical ignoring of inappropriate behaviour (not student)
- Revised seating plan and relocation of student/s
- Individual positive reinforcement for appropriate behaviour
- Class wide incentives
- Reminders of incentives or class goals
- Redirection



- Low voice and tone for individual instructions
- Give 30 second 'take-up' time for student/s to process instruction/s
- Reduce verbal language
- Break down tasks into smaller chunks
- Provide positive choice of task order (e.g. "Which one do you want to start with?")
- Prompt student to take a break or time away in class
- Model appropriate language, problem solving and verbalise thinking process (e.g. "I'm not sure what is the next step, who can help me?")
- Provide demonstration of expected behaviour
- Peer consequence (e.g. corrective feedback to influential peer demonstrating same problem behaviour)
- Private discussion with student about expected behaviour
- Reprimand for inappropriate behaviour
- Warning of more serious consequences (e.g. removal from classroom)
- Detention

### Focused

Class teacher is supported by other school-based staff to address in-class problem behaviour. This may include:

- Functional Behaviour Analysis
- Individual student behaviour support strategies (e.g. Individual Behaviour Support Plan)
- Targeted skills teaching in small group
- Time Out (for reflection)
- Discipline Improvement Plan
- Counselling and guidance support
- Self-monitoring plan
- Check in / Check Out strategy
- Teacher coaching and debriefing
- Referral to Student Services Support Team
- Case Management
- Stakeholder meeting with parents/carers and external agencies

### Intensive

School Leadership Team work in consultation with Student Support Services to address persistent or ongoing serious problem behaviour. This may include:

- Functional Behaviour Analysis based individual support plan
- Complex case management and review
- Risk Evaluation Plan
- Stakeholder meeting with parents/carers and external agencies including regional specialists
- Temporary removal of student property (e.g. mobile phone)
- Intensive re-setting of expectations external to the classroom facilitated by members of the school student support team.
- Short term suspension (up to 10 school days)
- Long term suspension (up to 20 school days)
- Charge related suspension (student has been charged with a serious criminal offence is suspended from school until the charge has been dealt with by the relevant justice authorities)



- Suspension pending exclusion (student is suspended from school pending a decision by the Director-General or delegate (Principal) about their exclusion from school)
- Exclusion (student is excluded from a particular state school site, a group of state schools or all state schools in Queensland for a defined period of time or permanently)
- Cancellation of enrolment for students older than compulsory school age who refuse to participate in the educational program provided at the school.

### Behaviour for Learning- Understanding Expectations (BLUE room)

The Willows State School takes into consideration the individual circumstances of students when applying individual behaviour support or applying consequences for inappropriate behaviour.

The Willows State School's BLUE Room is a calm, respectful 'classroom' environment that:

- Assists students to take responsibility for their behaviour
- Provides a supervised environment
- Allows time for reflection
- Provides support
- Emphasises to students that The Willows Learners are Safe, Respectful and Responsible

### Process:

- The student completes a reflection sheet after a conference with the Behaviour Reflection Room supervisor where they identify the rules/ expectations that need to be addressed and supported
- A letter is sent home for parents/carers to discuss with the student. The letter is to be signed and returned to the BLUE room the next day
- No phone calls are made to parents/carers as it is important for the student to take responsibility for their behaviour and to present the reflection sheet and incident report to their parents/carers
- During 'BLUE Room' time:
  - Students eat their lunch the first half of the break
  - During the second half of the break students engage in supportive activities eg social skilling, restorative practices, supervised play, conferencing, structured play, resilience building etc
- Students remain monitored until they return the signed letter from parents/carers
- Sport and extra-curricular activities may be compromised when students attend the BLUE room.

### School Disciplinary Absences

A School Disciplinary Absence (SDA) is an enforced period of absence from attending a Queensland state school, applied by the Principal as a consequence to address poor student behaviour. There are four types of SDA:

- Short suspension (1 to 10 school days)
- Long suspension (11 to 20 school days)
- Charge-related suspension
- Exclusion (period of not more than one year or permanently).

At The Willows State School, the use of any SDA is considered a very serious decision. It is typically only used by the Principal when other options have been exhausted or the student's



behaviour is so dangerous that continued attendance at the school is considered a risk to the safety or wellbeing of the school community.

Parents/carers and students may appeal a long suspension, charge-related suspension or exclusion decision. A review will be conducted by the Director-General or their delegate, and a decision made within 40 school days to confirm, amend/vary or set aside the original SDA decision by the Principal.

The appeal process is a thorough review of all documentation associated with the SDA decision and provides an opportunity for both the school and the family to present their case in the matter. Time is afforded for collection, dissemination and response to the materials by both the school and the family. It is important that the purpose of the appeal is understood so that expectations are clear, and appropriate supports are in place to ensure students can continue to access their education while completing their SDA.

#### **Re-entry following suspension**

Students who are suspended from The Willows State School will be invited to attend a re-entry meeting on the day of their scheduled return to school. The main purpose of this meeting is to welcome the student, with their parent/s, back to the school. It is not a time to review the student's behaviour or the decision to suspend, the student has already received a consequence through their disciplinary absence from school. The aim of the re-entry meeting is for school staff to set the student up for future success and strengthen home-school communication.

It is not mandatory for the student or their parents/carers to attend a re-entry meeting. It may be offered as a support for the student to assist in their successful re-engagement in school following suspension.

#### Arrangements

The invitation to attend the re-entry meeting will be communicated in writing, usually in a OneSchool letter. Re-entry meetings are short and kept small with school support personnel attending with the student and their parent/s.

A record of the meeting is saved in OneSchool, under the contact tab, including any notes or discussions occurring during the meeting.

#### Structure

The structure of the re-entry meeting is focussed on making the student and their family feel welcome back into the school community with proactive steps to move forward.

#### Possible agenda:

- Welcome back to school
- Check in on student wellbeing
- Discuss any recent home changes
- Offer information about supports available (e.g. guidance officer)
- Set a date for follow-up if needed
- Thank student and parent/s for attending
- Walk with student to classroom

#### Reasonable adjustments

In planning the re-entry meeting, school staff will consider reasonable adjustments needed to support the attendance and engagement of the student. This includes selecting an appropriate and accessible meeting space, organising translation or interpretation services or supports (e.g. AUSLAN), provision of written and/or pictorial information and other relevant accommodations



The inclusion of support staff, such as Guidance Officer, Head of Department - Curriculum, Head of Department – Student Services, Head of Special Education Services may also offer advice to the Deputy Principal to ensure a successful outcome for the student re-entering the school.

### **School Policies**

The Willows State School has tailored school discipline policies designed to ensure students, staff and visitors work cooperatively to create and maintain a supportive and safe learning environment in alignment with departmental policies. Please ensure that you familiarise yourself with the responsibilities for students, staff and visitors outlined in the following policies:

- The Code of Conduct for School Students Travelling on Buses
- Temporary removal of student property
- Use of mobile phones and other devices by students
- Preventing and responding to bullying
- Appropriate use of social media

### The Code of Conduct for School Students Travelling on Buses

### The Code of Conduct for School Students Travelling on Buses

The Code applies to all school students in Queensland who use buses either to travel to and from school or for other school-related activities, for example, school sports, excursions and camps. In implementing the Code, a collaborative approach by all stakeholders involved in the safe travel of school students is critical to encourage and reinforce appropriate behaviour on buses.

#### **Responsibilities of Students:**

- Be responsible for their own behaviour
- Act safely and responsibly
- Follow driver instructions and bus rules
- Respect themselves and others, including their own and others' property
- Understand and accept the consequences of bus misconduct (which can include refusal of travel)

#### **Responsibilities of Parents/carers:**

- Ensure their children are capable of travelling independently
- Ensure the safe travel of children to and from the bus service
- Teach their children about bus safety rules and appropriate behaviour, the Code and consequences for misconduct (which can include refusal of travel)
- Communicate respectfully and cooperate with the driver, bus operator and school in managing misconduct

### **Responsibilities of School staff:**

- Collaborate with stakeholders in implementing the Code
- Support bus operators in the application of the Code's procedures and processes
- Reinforce safe bus travel and the Code's messages in school based processes
- Facilitate effective communication between bus operators and students/parents/carers



### **Temporary Removal of Student Property**

The removal of any property in a student's possession may be necessary to promote the caring, safe and supportive learning environment of the school, to maintain and foster mutual respect between all state school staff and students. The **Temporary removal of student property by school staff procedure** outlines the processes, conditions and responsibilities for state school principals and school staff when temporarily removing student property.

In determining what constitutes a reasonable time to retain student property, the Principal or state school staff will consider:

- the condition, nature or value of the property
- the circumstances in which the property was removed
- the safety of the student from whom the property was removed, other students or staff members
- good management, administration and control of the school

The Principal or state school staff determine when the temporarily removed student property can be returned, unless the property has been handed to the Queensland Police Service.

The following items are explicitly prohibited at The Willows State School and will be removed if found in a student's possession:

- illegal items or weapons
- imitation guns or weapons
- old bullet shells
- potentially dangerous items
- drugs\*\* (including tobacco, vapes)
- alcohol
- aerosol deodorants or cans (including spray paint)
- explosives (e.g. fireworks, flares, sparklers)
- flammable solids or liquids (e.g. lighters)
- poisons
- inappropriate or offensive material

No knives of any type are allowed at school or any item that can be used as a weapon, for example a chisel. Knives needed for school activities will be provided by the school, and the use of them will be supervised by school staff. In circumstances where students may be required to have their own knives or sharp tools for particular subjects the school will provide information about the procedures for carrying and storing these items at school.

#### Responsibilities

State school staff at The Willows State School:

- do not require the student's consent to search school property such as lockers, desks or laptops that are supplied to the student through the school
- may seize a student's bag where there is suspicion that the student has a dangerous item (for example, a knife) in their school bag, prior to seeking consent to search from a parent or calling the police
- require consent from the student or parent to examine or otherwise deal with the temporarily removed student property. For example, staff who temporarily remove a



mobile phone from a student are not authorised to unlock the phone or to read, copy or delete messages stored on the phone

- there may, however, be emergency circumstances where it is necessary to search a student's property without the student's consent or the consent of the student's parents/carers (e.g. to access an EpiPen for an anaphylactic emergency)
- principals or state school staff do not have the authority to search the person of a student, if a search is considered necessary the police should be called to make such a determination.

Parents/carers of students at The Willows State School:

- ensure children do not bring property onto school grounds or other settings used by the school (e.g. camp, sporting venues) that:
  - is prohibited according to The Willows State School Student Code of Conduct
  - o is illegal
  - o puts the safety or wellbeing of others at risk
  - does not preserve a caring, safe, supportive or productive learning environment
     does not maintain and foster mutual respect
- collect temporarily removed student property as soon as possible after they have been notified by the principal or state school staff that the property is available for collection.

Students of The Willows State School:

- do not bring property onto school grounds or other settings used by the school (e.g. camp, sporting venues) that:
  - o is prohibited according to The Willows State School Student Code of Conduct
  - o is illegal
  - o puts the safety or wellbeing of others at risk
  - does not preserve a caring, safe, supportive or productive learning environment
     does not maintain and foster mutual respect
- collect their property as soon as possible when advised by the Principal or state school staff it is available for collection.

### Use of mobile phones by students

### 'Away for the day'

#### Important to note:

• Under the guidelines, mobile phones and wearable devices include mobile phones, smartwatches, handheld devices and other emerging technologies which have the ability to connect to telecommunication networks or the internet.

• These guidelines do not apply to personal or school-owned devices, such as iPads, tablets or laptops, that are approved for educational use as part of the school's Bring Your Own Device (BYOx) program.

### Student use of mobile phones and wearable devices at school:

From Term 1 2024, all state school students must keep their mobile phones switched off and 'away for the day' during school hours. Notifications on wearable devices, such as smartwatches, must be switched off so that phone calls, messages and other notifications cannot be sent or received during school hours.

These guidelines also apply to student attendance at school activities, such as representative school sport, excursions and camps, unless otherwise determined by the school principal.



Students may only use their mobile phone or have wearable device notifications enabled during these times if they are participating in a teacher-led educational activity that complies with the school's local implementation approach, or have an approved exemption for medical, disability and/or wellbeing reasons.

Students are permitted to use mobile phones after school once they are out of the school grounds. The students will hand them into the office on arrival where they will be kept safe for the school day. Students will need to sign their phone in and out with the office staff.

### Individual circumstances

Consideration of individual circumstances must be given to students who require temporary or ongoing exemptions to the school's local implementation approach, including where:

- the mobile phone or wearable device is used by the student to monitor or manage a medical
- condition (in accordance with the *Managing students' health support needs at school* procedure) • the mobile phone or wearable device is used as an agreed reasonable adjustment for a student
- with disability or learning difficulties
- the mobile phone or wearable device is used by the student as an augmentative or alternative communication system or as a tool to access and participate in the environment, e.g. navigation or object/people identification applications

The explicit teaching of responsible use of devices is a critical component of digital literacy. The knowledge and confidence to navigate and use these technologies safely while developing digital literacy is a responsibility shared between parents/carers, school staff and students.

### Supporting responsible use of mobile phones

In determining our school approach to students who do not meet the expectations stated in these guidelines, it is necessary to ensure that our responses are proportionate and equitable and take into consideration the individual circumstances of each student. This means making decisions that are reasonable for the situation.

Some examples include:

- providing a verbal reminder to the student about expected behaviour
- directing the student to place the mobile phone in storage in the office
- directing the student to switch off notifications on their wearable device
- removing the device temporarily and returning to the student or requesting their parent collect the device at the conclusion of the school day
- applying an in-school consequence
- increasing staff supervision of use in circumstances where the student requires access
- to their mobile phone or wearable device for medical, disability and/or wellbeing reasons.

Mobile phones and wearable devices that have been temporarily removed from the student must be stored and retained in accordance with the department's *Temporary removal of student property by school staff* procedure.

### Use of ICT facilities and devices by students

**Responsibilities of Students** 



It is **acceptable** for students at The Willows State School to:

- use computers, laptops and iPads or other devices for
  - assigned class work and assignments set by teachers
  - developing appropriate literacy, communication and information skills
  - authoring text, artwork, audio and visual material for publication on the intranet or internet for educational purposes as supervised and approved by the school
  - conducting general research for school activities and projects
  - communicating or collaborating with other students, teachers, parents/carers or experts in relation to school work
  - accessing online references such as dictionaries, encyclopaedias, etc.
  - researching and learning through the department's eLearning environment
- be courteous, considerate and respectful of others when using a device

### It is **unacceptable** for students at The Willows State School to:

• invade someone's privacy by recording personal conversations or daily activities and/or the further distribution of such material

- download, distribute or publish offensive messages or pictures
- use obscene, inflammatory, racist, discriminatory or derogatory language
- use language and/or threats of violence that may amount to bullying and/or harassment, or even stalking
- insult, harass or attack others or use obscene or abusive language
- damage computers, printers or network equipment
- commit plagiarism or violate copyright laws
- ignore teacher directions for the use of online email and online communication forums
- knowingly download viruses or any other programs capable of breaching the department's network security
- use in-phone cameras anywhere a normal camera would be considered inappropriate, such as in change rooms or toilets.
- use of school images, logos or school name used inappropriately that bring the school into disrepute

At all times, while using ICT facilities and devices supplied by the school, students will be required to act in line with the of The Willows State School Student Code of Conduct.

In addition, staff, students and their parents/carers:

- understand the responsibility and behaviour requirements as outlined by the School Behaviour Expectations Matrix and Laptop Use Expectations (Appendices 1 & 7) that come with accessing the department's ICT network facilities
- ensure they have the skills to report and discontinue access to harmful information if presented via the internet or email
- be aware that:
- the school is not responsible for safeguarding information stored by students on departmentally-owned student computers or mobile devices
- schools may remotely access departmentally-owned student computers or mobile devices for management purposes
- students who use the school's ICT facilities and devices inappropriately may be subject to disciplinary action by the school



- despite strict internal departmental controls to manage content on the internet, illegal, dangerous or offensive information may be accidentally displayed
- staff will always exercise their duty of care, by avoiding or reducing access to harmful information but this also requires responsible ICT use by the student.

### Appropriate use of social media

The internet, mobile phones and social media provide wonderful opportunities for students to network and socialise online. While these technologies provide positive platforms for sharing ideas, they also have the potential to cause pain and suffering to individuals, groups or even whole communities.

It's important to remember that sometimes negative comments posted about the school community have a greater impact than expected. Reputations of students, teachers, schools, principals and even parents/carers can be permanently damaged — and in some cases, serious instances of inappropriate online behaviour are dealt with by police and the court system.

Being aware of a few simple strategies can help keep the use of social media positive and constructive:

- Before you post something online, ask yourself if the community or individual really need to know. Is it relevant, positive and helpful?
- Remember that what you post online is a direct reflection of who you are. People will potentially form lasting opinions of you based on what you post online.
- Be a good role model. If things get heated online consider logging out and taking a few moments to relax and think. Hasty, emotive responses could inflame situations unnecessarily.
- Be mindful when commenting, try to keep it general and avoid posting anything that could identify individuals.

#### Is it appropriate to comment or post about schools, staff or students?

Parental and community feedback is important for schools and the department. If you have a compliment, complaint or enquiry about an issue at school, the best approach is to speak directly to the school about the matter, rather than discussing it in a public forum.

While many schools use social media to update parents/carers of school notices, the department prefers that parents/carers contact schools directly with a compliment, complaint or enquiry due to privacy considerations.

If you have raised an issue with a school or know that another person has, consider refraining from discussing those details on social media, particularly the names of anyone involved.

Keep comments calm and polite, just as you would over the telephone or by email. If you encounter negative or derogatory content online which involves the school, hinders a child's learning and/or affects the school community at large, contact the school principal.

### Possible civil or criminal ramifications of online commentary

A serious instance of inappropriate online behaviour may constitute a criminal offence and become a police matter. For example, online content may substantiate the offence of 'using a carriage service to menace, harass or cause offence' (Criminal Code Act 1995 (Cth) s. 474.17). School staff may contact their union or obtain personal legal advice if they feel that online



content seriously impacts their reputation. Defamatory online content may give rise to litigation under the Defamation Act 2005 (Qld).

### What about other people's privacy?

If you upload photos of your children, be mindful of who might be in the background. You might be happy to share your child's successes with your friends and family via social media, but some parents/carers are not. If you are tagging or naming students, consider that other parents/carers may not want their child's name attached to images online.

### What if I encounter problem content?

Taking the following steps may help resolve the issue in a constructive way:

- refrain from responding
- take a screen capture or print a copy of the concerning online content
- if you consider problem content to be explicit, pornographic or exploitative of minors, you should keep a record of the URL of the page containing that content but NOT print or share it. The URL can be provided to the police as needed
- block the offending user and report the content to the social media provider.

### **Preventing and Responding to Bullying**

The Willows State School uses the <u>Student Learning and Wellbeing Framework</u> to promote positive relationships and the wellbeing of all students, staff and visitors at the school.

Our staff know student learning is optimised when they feel connected to others and experience safe and trusting relationships. Students who feel secure are more likely to be active participants in their learning and to achieve better physical, emotional, social and educational outcomes. Teachers who feel valued and supported are more likely to engage positively with students and build stronger connections within the school community. Parents/carers who are positively engaged with their child's education leads to improved student self-esteem, attendance and behaviour at school. Enhancing the wellbeing of students and their educators delivers overall long-term social, health and economic benefits to the Australian community.

The Willows State School has a Student Leadership Team which includes a subcommittee of Student Council. Representatives from year four to six, meet with members of the School Leadership Team to discuss ideas to improve student wellbeing, engagement and learning outcomes.





### Leadership

Principals and school leaders play an active role in building a positive learning environment where the whole school community feels included, connected, safe and respected.

#### Inclusion

All members of the school community actively participate in building a welcoming school culture that values diversity, and fosters positive, respectful relationships.

### **Student voice**

Students actively participate in their own learning and wellbeing, feel connected and use their social and emotional skills to be respectful, resilient and safe.

#### **Partnerships**

Families and communities collaborate as partners with the school to support student learning, safety and wellbeing.

### Support

School staff, students and families share an understanding of wellbeing and positive behaviour and how this supports effective teaching and learning.

Through the Positive Behaviour for Learning Framework all stakeholders are contributing to the implementation of strategies that enhance wellbeing, promote safety and counter violence, bullying and abuse in all online and physical spaces.

### Bullying

The agreed national definition for Australian schools describes bullying as:

- ongoing and deliberate misuse of power in relationships through repeated verbal, physical and/or social behaviour that intends to cause physical, social and/or psychological harm;
- involving an individual or a group misusing their power, or perceived power, over one or more persons who feel unable to stop it from happening;
  - happening in person or online, via various digital platforms and devices and it can be obvious (overt) or hidden (covert). Bullying behaviour is repeated, or has the potential to be repeated, over time (for example, through sharing of digital records);



• having immediate, medium and long-term effects on those involved, including bystanders. Single incidents and conflict or fights between equals, whether in person or online, are not defined as bullying.

Behaviours that do not constitute bullying include:

- mutual arguments and disagreements (where there is no power imbalance)
- not liking someone or a single act of social rejection
- one-off acts of meanness or spite
- isolated incidents of aggression, intimidation or violence.

However, these conflicts are still considered serious and need to be addressed and resolved. At The Willows State School our staff will work to quickly respond to any matters raised of this nature in collaboration with students and parents/carers.

The following flowchart explains the actions The Willows State School teachers will take when they receive a report about student bullying, including bullying which may have occurred online or outside of the school setting. Please note that the indicative timeframes will vary depending on the professional judgment of teachers who receive the bullying complaint and their assessment of immediate risk to student/s.

### **Bullying response flowchart**

Please note these timelines may be adjusted depending on the unique circumstances and risk associated with each situation. This is at the professional judgment of the staff involved. Timeframes should be clearly discussed and agreed with student and family. If your child reports they are being bullied contact the classroom teacher in the first instance to discuss.

Order of key contacts for students and parents to report bullying:

### Cyberbullying

Cyberbullying is treated at The Willows State School with the same level of seriousness as inperson bullying. The major difference with cyberbullying however, is that unlike in-person bullying, cyberbullying follows students into their community, their homes and their bedrooms, giving them no opportunity to escape the harassment or abuse during the evening, weekends or holidays.

In the first instance, students or parents/carers who wish to make a report about cyberbullying should approach the regular class teacher or Deputy Principal for assistance in preventing and responding to cyberbullying.

It is important for students, parents/carers and staff to know that state school principals have the authority to take disciplinary action to address student behaviours that occur outside of school hours or school grounds. This includes cyberbullying. Parents/carers and students who have concerns about cyberbullying incidents occurring during school holidays should immediately seek assistance through the <u>Office of e-Safety Commissioner</u> or the Queensland Police Service.

Parents/carers or other stakeholders who engage in inappropriate online behaviour towards students, staff or other parents/carers may be referred to the Office of the e-Safety Commissioner and/or the Queensland Police Service.

### **Cybersafety and Reputation Management**

The Department of Education employs a dedicated team of experts to assist in maintaining the integrity of the department's reputation with regards to cybersafety and reputation management issues.

This team provides **direct support for schools** to respond to concerns of inappropriate online behaviour and misuse of information and communication technology.

The team provides a <u>guide for parents/carers</u> with important information about cybersafety and cyberbullying, and suggestions about what you can do if your child is a target or responsible for inappropriate online behaviour.

### **Student Intervention and Support Services**

The Willows State School recognises the need to provide intervention and support to all students involved in incidents of bullying, including cyberbullying.

Students who have been subject or witness to bullying have access to a range of internal support staff, as identified in the 'Student Support Network' section earlier in this document.

Students who engage in bullying behaviours towards others will also be provided with support to assist them to use more socially acceptable and appropriate behaviours in their interactions. This includes counselling, social development programs, referral to mental health services or involvement in a restorative conversation. School disciplinary measures may also be used to reinforce the seriousness with which the community takes all incidents of bullying.

#### How to manage online incidents that impact your school

#### Student protection

If at any point the principal forms a reasonable suspicion that a student has been harmed or is at risk of harm, they have a responsibility to respond in accordance with the <u>Student</u> protection procedure.


#### **Explicit images**

If the investigation involves naked or explicit images of children, staff should not save, copy, forward or otherwise deal with the content, as per the Temporary removal of student property by school staff procedure. This includes onto OneSchool records. Refer to the investigative process outlined in 'Responding to incidents involving naked or explicit images of children' from the <u>Online Incident</u> management guidelines.

### **Restrictive Practices**

School staff at The Willows State School need to respond to student behaviour that presents a risk of physical harm to the student themselves or others. It is anticipated that most instances of risky behaviour can be de-escalated and resolved quickly. On some rarer occasions, a student's behaviour may continue to escalate and staff need to engage immediately with positive and proactive strategies aimed at supporting the student to manage their emotional arousal and behaviour.

In some very rare situations, where there is immediate risk of physical harm to the student or other people, and when all other alternative strategies have failed to reduce the risk, it may be necessary for staff to use restrictive practices.

The use of restrictive practices will always be as a last resort, when there is no other available option for reducing immediate risk to the student, staff or other people. Restrictive practices are not used for punishment or as a disciplinary measure.

The department's **<u>Restrictive practices procedure</u>** is written with consideration for the protection of everyone's human rights, health, safety and welfare. There are six fundamental principles:

- 1. Regard to the human rights of those students
- 2. Safeguards students, staff and others from harm
- 3. Ensures transparency and accountability
- 4. Places importance on communication and consultation with parents/carers
- 5. Maximises the opportunity for positive outcomes, and
- 6. Aims to reduce or eliminate the use of restrictive practices.

Very rarely restrictive practices will be planned and staff will employ, when necessary, prearranged strategies and methods (of physical restraint/ mechanical restraint/ clinical holding) which are based upon behaviour risk assessment or clinical health need and are recorded in advance. The use of planned strategies will only be where there is foreseeable immediate risk consistent with the Restrictive Practices procedure.

Seclusion will not be used as a planned response and will only be used in serious circumstances for managing an unforeseeable situation in an emergency. It will be used for the shortest time possible and in a safe area that presents no additional foreseeable risk to the student. In such emergencies, a staff member will observe the student at all times and seclusion will cease as soon as possible.

Following the use of any restrictive practice, a focused review will help staff to understand how they responded to the risk in any incident that involved the use of a restrictive practice. Staff will consider whether there are other options for managing a similar situation in the future.

All incidents of restrictive practices will be recorded and reported in line with departmental procedures.



### **Critical Incidents**

A critical incident is defined as an occurrence that is sudden, urgent, and usually unexpected, or an occasion requiring immediate action (e.g. in the community, on the road). The aim in these situations is to bring the behaviour of the student under rapid and safe control. It is not a time to try to discipline the student; it is a crisis management period only.

Staff follow emergency management plan processes when attending to a critical incident that seriously endangers the student or others.

The principal will communicate with the relevant members of the school community using school communication channels to advise of the incident and to offer support to those needed.



### Conclusion

The Willows State School staff are committed to ensuring every student is supported to feel safe, welcome and valued in our school. There may, however, be occasions where parents/carers need to raise a concern or make a complaint about an issue if felt that it is adversely affecting their child's education.

All Queensland state schools are committed to ensuring that all complaints - whether they relate to a school staff member or a school's operations - are dealt with in a fair and equitable manner. As a parent or carer, you can express dissatisfaction with the service or action of the Department of Education or its staff, including decisions made or actions taken in a school and/or by the local regional office.

As a complainant, it is your responsibility to:

- give us a clear idea of the issue or concern and your desired solution
- provide all the relevant information when making the complaint
- understand that addressing a complaint can take time
- cooperate respectfully and understand that unreasonable, abusive, or disrespectful conduct will not be tolerated
- let us know if something changes, including if help is no longer needed.

# The Department of Education may not proceed with your complaint if your conduct is unreasonable.

In most instances, staff members are told of complaints made about them and offered the right of reply. A complainant also has the right to have a support person throughout the process.

The following three-step approach assists parents/carers and school staff in reaching an outcome that is in the best interests of the student:

1. **Early resolution**: discuss your complaint with the school

The best place to raise any concerns is at the point where the problem or issue arose. You can make an appointment at the school to discuss your complaint with your child's teacher or the principal.

Complaints may also be lodged by telephone, writing or in electronic format. Email addresses can be accessed through the <u>schools directory</u>.

Internal review: <u>contact the local Regional Office</u>
 If, after taking the early resolution step, you are dissatisfied with the outcome of
 your complaint or how the complaint was handled, you can ask the local <u>regional
 office</u> to conduct a review.

#### 3. External review: contact a review authority

if you are dissatisfied after the internal review, you may wish to contact a review authority, such as the Queensland Ombudsman, and request an independent, external review. More information about external review options is available at www.ombudsman.gld.gov.au.




